MANAGEMENT LETTER ON FINANCIAL STATEMENTS OF AFRICA CENTRE OF EXCELLENCE (ACEII) IN PHYTOCHEMICALS, TEXTILES AND RENEWABLE **ENERGY (PTRE) PROJECT FOR THE YEAR ENDED 30 JUNE 2020**

1.0 Introduction

The financial statements of Africa Centre of Excellence (ACEII) in Phytochemicals, Textiles and Renewable Energy (PTRE) Project are subject to audit by the Auditor-General in accordance with the provisions of Article 229 of the Constitution of Kenya and Section 35 of the Public Audit Act, 2015.

The audit of Africa Centre of Excellence (ACEII) in Phytochemicals, Textiles and Renewable Energy (PTRE) Project for the year ended 30 June, 2020 was completed and the purpose of this letter is to bring to your attention the findings that were revealed during the audit.

2.0 Scope and Determination of Responsibility

The audit was conducted in accordance with International Standards for Supreme Audit Institutions. These standards require that the audit is planned and performed so as to obtain reasonable assurance that, in all material respects, fair presentation is achieved in the annual financial statements.

An audit includes:

- Examination on a test basis of evidence supporting the amounts and disclosures in the financial statements;
- Assessment of the accounting principles used and significant estimates made by management; and
- Evaluation of the overall financial statements presentation.

The audit will also include an examination, on a test basis, of evidence supporting compliance, in all material respects, with the relevant laws and regulations which came to our attention and are applicable to financial matters.

The matters mentioned in this letter are therefore those that were identified through tests considered necessary for the purpose of the audit and it is possible that there might be other matters and/or weaknesses that were not identified.

The financial statements, maintenance of effective control measures and compliance with laws and regulations are the responsibility of the Accounting Officer. Our responsibility is to express an opinion on these financial statements.

3.0 Respective Responsibilities of the Management and the Auditor-General

The management is responsible for the preparation and fair presentation of the Financial Statements in accordance with International Public Sector Accounting Standards (Cash Basis) and for such internal control as management determines is necessary to enable the preparation of Financial Statements that are free from material misstatement, whether due to fraud or error.

The Responsibility of the Auditor-General is to express an independent opinion on the Financial Statements based on the audit findings.

Management Response

4.2.2 Unjustified Expenditure

Criteria

Article II.19.1(f) stipulates that eligible costs of action are costs actually incurred by the beneficiary and which are reasonable, justified and comply with the principle of sound financial management, in particular regarding economy and efficiency.

Finding

Included in the set up institutional framework for commencement of the ACEII figure of Kshs.12,830,089 reflected in note 9.7 to the financial statements is an expenditure of Kshs. 2,311,250 incurred on meeting for staff members held in Kisumu as shown in **Appenix II.** No verifiable explanation was provided for not holding the meeting in the University headquarters. Further, Included in the set up institutional framework for commencement of the ACEII expenditure of Kshs.12,830,089 is an expenditure of Kshs.1,327,028 as shown below which was incurred as accommodation allowances for non-Kenyans participating in in Intra-Africa Academic Mobility Scheme meeting in Brussels, of 6-7, February 2020. There was also no acknowledgement from the beneficiaries that they received the money.

Effect

Management may be in breach of the General Disbursement Guidelines for World Bank Projects and the propriety of accommodation allowances of Kshs.1,327,028 paid to non-

4.0 Audit Findings

4.1 Purchase of Goods and Services

4.2.1 Direct Expensing of Imprests

Criteria

Regulations 93 of the Public Finance Management (National Government) regulations, 2015 states that an imprest shall be issued for a specific purpose, and any payments made from it, shall be only for the purposes specified in the imprest warrant. Temporary imprests shall be issued mainly in respect of official journeys and are intended to provide officers with funds with which they can meet travelling, accommodation and incidental expenses. A holder of a temporary imprest shall account or surrender the imprest within 7 working days after returning to duty station. In the event of the imprest holder failing to account for or surrender the imprest on the due date, the accounting officer shall take immediate action to recover the full amount from the salary of the defaulting officer with an interest at the prevailing Central Bank Rate. If the accounting officer does not recover the temporary imprest from the defaulting officer as provided for in this regulation the accounting Officer commits an offence as provided for under the Act.

Finding

Included in the purchase of goods and service figure of Kshs.53,464,128 reflected in the statement of receipts and payments are imprests issued of Kshs.22,236,807 as shown in **Appendix I** which were directly expensed. A further review of the records made available indicated that the imprests were issued to officers out on official duties. However, there were no approved travel programs/work plans in the year and no specific budget was prepared for the travelling and accommodation. Further, officers were issued with more than one imprest before surrendering the previous imprest.

Effect

The expenditure on purchase of goods and services has been overstated and the management is in breach of laws and regulations on issuance of imprest.

Recommendation

The management should ensure that imprests are expensed after the beneficies have accounted for the imprest and no additional imprest is issued officers who have not accounted for imprest previously issued. Further, imprest not accounted for or surrendered should be recovered from the defaulting officer.

Kenyans participating in Intra-Africa Academic Mobility Scheme meeting in Brussels could not be confirmed.

Recommendation

The management of Moi University should adhere to the disbursement guidelines.

Management Response

4.2 Acquisition of Assets

Criteria

Paragraph 27 of the International Public Sector Accounting Standards (IPSAS) 1 states that financial statements shall present fairly the financial position, financial performance, and cash flows of an entity. Fair presentation requires the faithful representation of the effects of transactions, other events, and conditions in accordance with the definitions and recognition criteria for assets, liabilities, revenue, and expenses set out in IPSASs. The application of IPSASs, with additional disclosures when necessary, is presumed to result in financial statements that achieve a fair presentation.

Finding

The statement of receipts and payment for the year ended 30 June 2020 reflects acquisition of assets figure of Kshs.12,131,482 which includes Kshs.9,948,386 expenditure incurred on strengthen research capacity excellence - quality and productivity expenditure. A review of the payment vouchers availed for audit revealed that strengthen research capacity excellence - quality and productivity expenditure of Kshs.9,948,386 include an expenditure of Kshs.8,208,000 incurred on the procurement of a plasma enhanced chemical vapor deposition (PECVD). However, the expenditure had not been budgeted for and was not included in the procurement plan for the year under review. Further, the strengthen research capacity excellence - quality and productivity expenditure of Kshs.9,948,386 include an expenditure of Kshs.471,500 incurred on allowances for facilitators for biogas training for high schools.

Effect

The management irregularly procured a plasma enhanced chemical vapor deposition (PECVD) and the validity and accuracy of strengthen research capacity excellence - quality and productivity expenditure of Kshs.9,948,386 for the year ended 30 June 2020 could not be confirmed.

Recommendation

The management should ensure that they follow the law when acquiring assets.

Management Response

4.3 Accounts Receivables-Imprest and Advances

Criteria

Regulation 93 (4)(c) of the Public Finance Management (National Government) regulations, 2015 requires accounting officer to ensure that before issuing a temporary imprest, the applicant should be recorded in an imprest register including the amount applied for.

Finding

The statement of financial assets reflects accounts receivables-imprest and advances figure of Kshs.5,309,330. However, the imprest register was not availed for audit verification.

Effect

The validity, accuracy and existence of accounts receivables- imprest and advances balance of Kshs.5,309,330 as at 30 June 2020 could not be confirmed.

Recommendation

The management should ensure that an imprest register is maintained for imprests issued from the project account

Management Response

4.4 Summary of Fixed Assets Register

Criteria

Regulation 136(1) of the Public Finance Management Regulations, 2015 requires that the accounting officer shall be responsible for maintaining of a register of assets under his/her control or possession.

Finding

Annex 2 to the financial statements reflects total assets figure of Kshs.49,752,771 which include office equipment, furniture and fittings of Kşhs.12,131,482 procured during the year. the assets register was not availed for audit verification.

Effect

The nature, number, physical location and fair value of the projects assets could not be ascertained.

Recommendation

The management should maintain an assets register as stipulated Regulation 136(1) of the Public Finance Management (National Government) Regulations, 2015.

Management Response

RESPONSE TO THE MANAGEMENT LETTER OF STATEMENTS FOR AFRICA CENTRE OF EXCELLENCE (ACEII) FOR THE YEAR ENDED 30 JUNE, 2020

We refer to your Management Letter dated 26th October, 2020 on the Financial Statements for the Africa Centre of Excellence (ACEII) Project for the year ended 30 June, 2020.

We wish to respond to the issues raised as follows:

1. DIRECT EXPENSING OF IMPRESTS

The University runs its Finance Management Information System on Navision and it is the basis of preparation of the Financial Statements of the ACEII Project on IPSAS Accrual basis of accounting.

Under the IPSAS Accrual basis of accounting that the University uses in its general operations, imprests are recognised as staff debtors and are only expenses when the respective imprests are accounted for.

In the preparation of these Financial Statements under IPSAS Cash basis of accounting, imprests were treated as advances and were only expenses upon the beneficiaries accounting for the imprests. Imprests that were not accounted for by the end of the year were disclosed in the Financial Statements under Note 9.11 to the Financial Statements, and were excluded from the amounts in the Statement of Receipts and Payments. The University maintained separate subsidiary records to recognise the imprests advances as cash under IPSAS Cash basis of accounting.

The imprest management system operated by the University does not allow any individual to have more than one imprest before surrender of the previous imprest advanced. During the year, we ensured that this was adhered to as provided for in the University policies and regulations. We confirm that the imprests that had not been accounted for as at year end have since been accounted for by the respective staff.

As indicated in the attached analysis of the payments/ imprests included in the Statement of Receipts and Payments, the Financial Statements have captured and expensed only imprests that have been duly accounted for. We have attached the same for your verification. (Annex1).

The project budgets for activities to be undertaken during the year and allocates funds for each activity code. The approved budget and the specific funds allocated for the activities are the basis on which all the expenditures related to the activities (including travel and accommodation expenses) are made.

We have attached the summary of the approved budget and the Centre's approved Annual Work Plan for your verification. (Annex 2 & 3).

We, therefore, request that you amend your observations in this regard in view of the explanations and documents given above.

2. UNJUSTIFIED EXPENDITURE Kes.2,311,250

The ACEII Project has been able to attract funds from other bodies in the fulfilment of its strategic goals of strengthening research capacity excellence and outreach service in Phytochemicals, Textiles and Renewable Energy, and increasing sustainability of research and training.

The funds that were used in paying the staff from various Universities were funds received from the European Union (Education, Audiovisual and Culture Executive Agency) for a Project called "Mobility for Innovative Renewable Energy Technologies (MIRET)". This Project involves Moi University and the following Universities:

Makerere University - Uganda

University of Sfax
 Tunisia

University of BUEA - Cameroon

University of Zambia - Zambia

Moi University is the coordinating University and receives the funds to facilitate the project activities. The expenditure indicated in your report was for an inception meeting for the Intra-Africa Academic Mobility Scheme under the Project that was held in Brussels and was attended by representatives from the participating Universities. The University, as the Coordinator, drew the funds that were remitted to the beneficiaries. We have attached evidence of acknowledgement of receipt of the funds that were signed by the respective persons. (Annex 4).

As explained above, the expenditure of these funds was governed by the Grant Agreement under the Intra-Africa Academic Mobility Scheme signed between the European Union and the University. The eligible expenditures under this grant include travel and visa costs, subsistence allowances, participation costs, research costs, among others. We have attached a copy of the Grant Agreement for your perusal. The funds were used as per the terms of the Grant Agreement. The University was not, therefore, in breach of the General Disbursement Guidelines for World Bank Projects in this regard.

The Centre has budgeted, under 1.6.1 in its Annual Approved Budget to have an Annual Meeting. This is a forum where the Centre engages the University Management and other stakeholders over various policy issues which require their attention and seeks their critical input and guidance. In this meeting, the Centre leadership and thematic leaders share the Centre activities during the year and its forward plans. This is an annual activity done prior to the annual partners meeting. It was held outside the University because it was intended to be held in an environment devoid of interruptions and also to serve as a group bonding session and had, therefore, to be in a facility that has these trainers/facilitators. It was more cost effective in this regard.

The meeting to discuss the PTRE building project was held amid the Covid-19 pandemic. Given the geographical dispersal of the staff and other stakeholders after the closure of the University in March 2020, Kisumu was considered to be a central place where the staff could meet. The University is in the process of developing designs for the construction of a PTRE building project. The Centre social safeguards team and Ministry of Public Works designs team were urgently required to engage to finalize on documents to be presented to the Moi University Management to consider and complete the approval process to launch the project.

3. ACQUISITION OF ASSETS

The Centre procured laboratory equipment (Plasma Enhanced Chemical Vapor Deposition (PECVD)) from Ms Finton Logistics at a cost of Kes.8,208,000 under the procurement plan that was originally in the 2017-2018 FY. The procurement process for this equipment was completed and notification/ LPO issued to the supplier at that time. The supplier was sourcing the equipment from overseas and, therefore, it took longer than had been anticipated to deliver and commission the equipment in the University. This was eventually done in 2019-2020 FY. The equipment was considered very critical in the training and research for postgraduate students in the Department of Renewable Energy.

As the Project operates on the cash basis of accounting, the Approved Plan for the Project for FY 2019/2020 was amended to facilitate the payment for this equipment. This was done by deferring some of the planned procurements for the Department of Renewable Energy amounting to USD85,000.

We hereby attach the revised Plan/ Financial budget (4.1.21) for FY 2019/2020 and the request from the Department for your perusal. (Annex 5).

The wrong classification under biogas expense (Kes.471,500) has been noted and financial statements rectified accordingly. (Annex7)

4. ACCOUNTS RECIEVEABLES - IMPREST AND ADVANCES

The University maintained a separate imprest register that controlled the issuance and

accounting for imprests. The register has details of the imprest holder, the date, the

cheque number, the amount issued, the amount surrendered etc.

We have attached the imprest register for your perusal.

5. SUMMARY OF FIXED ASSETS REGISTER

The University maintains an Assets Management module for the entire University

assets in its Enterprise Resource Planning (ERP) system. Additionally, the ACE II

Project maintains a separate asset register for all the assets relating to the Project.

We have attached a copy of the asset register for your verification.

6. CONCLUSION

REPORT OF THE AUDITOR-GENERAL ON AFRICA CENTRE OF EXCELLENCE (ACE II) IN PHYTOCHEMICALS, TEXTILES AND RENEWABLE ENERGY (PTRE) PROJECT FOR THE YEAR ENDED 30 JUNE 2020

REPORT ON THE FINANCIAL STATEMENTS

Qualified Opinion

I have audited the accompanying financial statements of Africa Centre of Excellence (ACE II) in Phytochemicals, Textiles and Renewable Energy (PTRE) Project set out on pages 16 to 37, which comprise the statement of financial assets as at 30 June 2020, and the statement of receipts and payments, statement of cash flows and statement of comparative budget and actual amounts for the year then ended, and a summary of significant accounting policies and other explanatory information in accordance with the provisions of Article 229 of the Constitution of Kenya and Section 35 of the Public Audit Act, 2015. I have obtained all the information and explanations which, to the best of my knowledge and belief, were necessary for the purpose of the audit.

In my opinion, except for the effects of the matter described in the Basis for Qualified Opinion section of my report, the financial statements present fairly, in all material respects, the financial position of Africa Centre of Excellence (ACE II) in Phytochemicals, Textiles and Renewable Energy (PTRE) Project as at 30 June, 2020, and (of) its financial performance and its cash flows for the year then ended, in accordance with International Public Sector Accounting Standards (Cash Basis) and comply with the Grant Agreement nr 2019-1973/006-001-Intra Africa Academic Mobility Scheme dated 3 December 2019.

Basis for Qualified Opinion

1.0 Purchase of Goods and Services

The statement of receipts and payments and note 9.7 to the financial statements reflects purchase of goods and service figure of Kshs.53,464,128 which includes an expenditure of Kshs.11,600,361 that was not adequately supported as indicated in **Appendix I**.

Under the circumstance, the validity, accuracy and propriety of purchase of goods and service expenditure of Kshs.11,600,361 for the year ended 30 June 2020 could not be confirmed.

2.0 Accounts Receivables - Imprests and Advances

The statement of financial assets reflects accounts receivables- imprest and advances figure of Kshs.5,309,330. However as reported in the previous year, the imprest register indicating the details of the imprest issued such as name of imprest holder, warrant number, amount of imprest, date of issue, and date of surrender was not availed for audit verification.

Under the circumstance, the validity, accuracy, completeness and existence of accounts receivables - imprest and advances balance of Kshs.5,309,330 as at 30 June 2020 could not be confirmed.

3.0 Summary of Fixed Assets Register

Annex 2 to the financial statements reflects total assets figure of Kshs.49,752,771 which include office equipment, furniture and fittings of Kshs.12,131,482 procured during the year. However, the assets register was not availed for audit confirmation and verification.

Consequently, the accuracy, completeness and existence of fixed assets value of Kshs.49,752,771 as at 30 June 2020 could not be ascertained.

The audit was conducted in accordance with International Standards of Supreme Audit Institutions (ISSAIs). I am independent of Africa Centre of Excellence (ACE II) in Phytochemicals, Textiles and Renewable Energy (PTRE) Project in accordance with ISSAI 30 on Code of Ethics. I have fulfilled other ethical responsibilities in accordance with the ISSAI and in accordance with other ethical requirements applicable to performing audits of financial statements in Kenya. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified opinion.

Key Audit Matters

Key audit matters are those matters that, in my professional judgment, are of most significance in the audit of the financial statements. Except for the matter(s) described in the Basis for Qualified Opinion section, I have determined that there are no other key audit matters to communicate in my report.

Other Matter

1.0 Budget Absorption and Performance

The statement of comparison of budget and actual under note 7 to the financial statements reflects approved expenditure budget of Kshs. 189,628,684 comprising of transfers from government entities of Kshs. 108,969,337, proceeds from domestic and miscellaneous receipts of Kshs.48,003. During the same period, the Project incurred expenditure of Kshs. 65,556,675 or 26% of the approved budget of Kshs. 255,688,515 resulting to overall underutilization of Kshs 190,131,840 or 74% as detailed below:

From the analysis, the Africa Centre of Excellence (ACE II) in Phytochemicals, Textiles and Renewable Energy (PTRE) received all funds budgeted for. The Project incurred Kshs.65,556,675 out of budgeted amount of Kshs.255,688,515 resulting to underutilization of Kshs 190,131,840 an indication that the activities planned for the year were not undertaken.

REPORT ON LAWFULNESS AND EFFECTIVENESS IN USE OF PUBLIC RESOURCES

Conclusion

As required by Article 229(6) of the Constitution, based on the audit procedures performed, except for the matter(s) described in the Basis for [Conclusion on Lawfulness and Effectiveness in Use of Public Resources/ Qualified Opinion] section of my report, I confirm that, nothing else has come to my attention to cause me to believe that public resources have not been applied lawfully and in an effective way.

Basis for Conclusion

1.0 Acquisition of Non -Financial Assets

Note 9.8 to the financial statements reflects strengthen research capacity excellence - quality and productivity expenditure of Kshs.9,948,386 which includes an expenditure of Kshs.8,208,000 incurred on the procurement of a plasma enhanced chemical vapor deposition (PECVD). However, the expenditure had not been budgeted for in the year under review and was not included in the procurement plan for the year under review. Management has explained that the procurement relates to 2017/2018 financial year and the notification and LPO were issued to the supplier. However, the letter of offer, acceptance letter, contract agreement, delivery notes, goods received note and inspection and acceptance report have not been availed to confirm the explanation.

Consequently, the management irregularly procured a plasma enhanced chemical vapor deposition (PECVD) and the validity and accuracy of strengthen research capacity excellence - quality and productivity expenditure of Kshs.8,208,000 for the year ended 30 June 2020 could not be confirmed.

The audit was conducted in accordance with ISSAI 4000. The standard requires that I comply with ethical requirements and plan and perform the audit to obtain assurance about whether the activities, financial transactions and information reflected in the financial statements are in compliance, in all material respects, with the authorities that govern them. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my conclusion.

REPORT ON INTERNAL CONTROLS EFFECTIVENESS, GOVERNANCE AND RISK MANAGEMENT SYSTEMS

Conclusion

As required by Section 7 (1) (a) of the Public Audit Act, 2015, based on the audit procedures performed, except for the matter(s) described in the Basis for [Conclusion on Effectiveness of Internal Controls, Risk Management and Governance/Qualified Opinion] section of my report, I confirm that, nothing has come to my attention to cause me to believe that internal controls, risk management and overall governance were not effective.

Basis for Conclusion

The audit was conducted in accordance with ISSAI 1315 and ISSAI 1330. The standards require that I plan and perform the audit to obtain assurance about whether effective processes and systems of internal control, risk management and governance were operating effectively, in all material respects. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my conclusion.

Responsibilities of Management and Those Charged with Governance

Management is responsible for the preparation and fair presentation of these financial statements in accordance with International Public Sector Accounting Standards (Cash Basis) and for maintaining effective internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error and for its assessment of the effectiveness of internal control, risk management and governance.

In preparing the financial statements, management is responsible for assessing the Africa Centre of Excellence (ACE II) in Phytochemicals, Textiles and Renewable Energy (PTRE) Project ability to continue as a going concern/ sustain services, disclosing, as applicable, matters related to going concern/ sustainability of services and using the going concern basis of accounting unless the management either intends to liquidate the Africa Centre of Excellence (ACE II) in Phytochemicals, Textiles and Renewable Energy (PTRE) Project or to cease operations, or have no realistic alternative but to do so.

Management is also responsible for the submission of the financial statements to the Auditor-General in accordance with the provisions of Section 47 of the Public Audit Act, 2015.

In addition to the responsibility for the preparation and presentation of the financial statements described above, management is also responsible for ensuring that the activities, financial transactions and information reflected in the financial statements are in compliance with the authorities which govern them, and that public resources are applied in an effective way.

Those charged with governance are responsible for overseeing the Africa Centre of Excellence (ACE II) in Phytochemicals, Textiles and Renewable Energy (PTRE) Project financial reporting process, reviewing the effectiveness of how the entity monitors compliance with relevant legislative and regulatory requirements, ensuring that effective processes and systems are in place to address key roles and responsibilities in relation Report of the Auditor-General on the Financial Statements of Africa Centre of Excellence (ACEII) for the Year Ended 30 June 2020

to governance and risk management, and ensuring the adequacy and effectiveness of the control environment.

Auditor-General's Responsibilities for the Audit

The audit objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion in accordance with the provisions of Section 48 of the Public Audit Act, 2015 and submit the audit report in compliance with Article 229(7) of the Constitution. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISSAIs will always detect a material misstatement and weakness when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

In addition to the audit of the financial statements, a compliance audit is planned and performed to express a conclusion about whether, in all material respects, the activities, financial transactions and information reflected in the financial statements are in compliance with the authorities that govern them and that public resources are applied in an effective way, in accordance with the provisions of Article 229(6) of the Constitution and submit the audit report in compliance with Article 229(7) of the Constitution.

Further, in planning and performing the audit of the financial statements and audit of compliance, I consider internal control in order to give an assurance on the effectiveness of internal controls, risk management and governance processes and systems in accordance with the provisions of Section 7 (1) (a) of the Public Audit Act, 2015 and submit the audit report in compliance with Article 229(7) of the Constitution. My consideration of the internal control would not necessarily disclose all matters in the internal control that might be material weaknesses under the ISSAIs. A material weakness is a condition in which the design or operation of one or more of the internal control components does not reduce to a relatively low level the risk that misstatements Report of the Auditor-General on the Financial Statements of Africa Centre of Excellence (ACEII) for the Year Ended 30 June 2020

caused by error or fraud in amounts that would be material in relation to the financial statements being audited may occur and not be detected within a timely period by employees in the normal course of performing their assigned functions.

Because of its inherent limitations, internal control may not prevent or detect misstatements and instances of non-compliance. Also, projections of any evaluation of effectiveness to future periods are subject to the risk that controls may become inadequate because of changes in conditions, or that the degree of compliance with the Africa Centre of Excellence (ACE II) in Phytochemicals, Textiles and Renewable Energy (PTRE) Project policies and procedures may deteriorate.

As part of an audit conducted in accordance with ISSAIs, I exercise professional judgement and maintain professional skepticism throughout the audit. I also:

- Identify and assess the risks of material misstatement of the financial statements,
 whether due to fraud or error, design and perform audit procedures responsive to
 those risks, and obtain audit evidence that is sufficient and appropriate to provide a
 basis for my opinion. The risk of not detecting a material misstatement resulting from
 fraud is higher than for one resulting from error, as fraud may involve collusion,
 forgery, intentional omissions, misrepresentations, or the override of internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the management.
- Conclude on the appropriateness of the management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Africa Centre of Excellence (ACE II) in Phytochemicals, Textiles and Renewable Energy (PTRE) Project ability to continue as a going concern or to sustain its services. If I conclude that a material uncertainty exists, I am required to draw attention in the auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify my opinion. My conclusions are based on the audit evidence obtained up to the date of my audit report. However, future events or

conditions may cause the Africa Centre of Excellence (ACE II) in Phytochemicals,

Textiles and Renewable Energy (PTRE) Project to cease to continue as a going

concern or to sustain its services.

Evaluate the overall presentation, structure and content of the financial statements,

including the disclosures, and whether the financial statements represent the

underlying transactions and events in a manner that achieves fair presentation.

Obtain sufficient appropriate audit evidence regarding the financial information and

business activities of the Africa Centre of Excellence (ACE II) in Phytochemicals,

Textiles and Renewable Energy (PTRE) Project to express an opinion on the financial

statements.

Perform such other procedures as I consider necessary in the circumstances.

I communicate with the management regarding, among other matters, the planned scope

and timing of the audit and significant audit findings, including any significant deficiencies

in internal control that are identified during the audit.

I also provide management with a statement that I have complied with relevant ethical

requirements regarding independence, and to communicate with them all relationships

and other matters that may reasonably be thought to bear on my independence, and

where applicable, related safeguards.

1. PURCHASE OF GOODS AND SERVICES

During the year under review the Project incurred and made payments through Payment Vouchers and Imprest Advances for various activities. The requests for imprest advances for project activities were supported by appropriate supporting documents. These imprests were duly accounted for with relevant supporting documents when they were surrendered.

In the draft report, we were requested to attach various documents which we have attached as indicated on Annex 1-27 of this report. As you will note from the documents, these expenses were duly and validly incurred for the Project.

We, therefore, request that you amend your report with regard to your observation on this matter.

2. ACCOUNTS RECEIVABLES - IMPREST AND ADVANCES

The University maintained and managed its imprest management system under the Navision ERP system. This system controlled the issuance and accounting for imprests and has imprest

ledgers for all staff. The register has details of the imprest holder, the date, the cheque number, the amount issued, the amount surrendered etc.

3. SUMMARY OF FIXED ASSETS REGISTER

The University maintains an Assets Management module for the entire University assets in its ERP system. In addition, the ACE II Project maintains a subsidiary asset register for all the assets relating to the Project.

We have attached the details of the fixed assets register relating to the office equipment, furniture and fittings procured during the year.....(Annex 29)

4. BUDGET ABSORPTION

The Project's planned activities during the year were negatively affected by exogenous factors, principally the Covid-19 Pandemic that forced the closure of the University in the third and fourth quarter.

The activities that were not undertaken due to the restrictions and health protocols relating to the Coronavirus pandemic were therefore postponed to the FY 2020/2021. These included procurement of equipment, staff exchange programmes, workshops and other external activities. Students' research projects that were being undertaken were also not concluded in time and new ones postponed due to suspension of academic programmes at the University.

Some of the equipment that had been procured were also not commissioned in time to facilitate the payment for the deliveries. Since the Project's financial statements are on cash basis, the payments could not be done in this financial year, thus resulting in under-absorption of the funds.

However, we have ensured that these funds are fully absorbed in FY 2020/2021. The Project will also earnestly undertake all the activities that had been postponed due to Covid-19 as per the guidelines of the Ministry of Education and Health.

5. ACQUISITION OF NON-FINANCIAL ASSETS

We have attached the following documents relating to the procurement of the Plasma Enhanced Chemical Vapour Deposition (PECVD) equipment as requested in the draft audit report:

- a) Letter of offer (Notification of award)
- b) Acknowledgement of receipt

- d) Contract between Moi University and Finton Logistics Limited
- e) Delivery note for the equipment
- f) Goods Received Note (GRN) for the equipment
- g) Inspection and Acceptance Certificate for the equipment

We therefore request that you review your observation on this matter accordingly.
